PROCEEDS OF CRIME

J. Andre Ouellette, Ouellette Rice

This topic will refer to the two streams whereby the state can recover monies or property associated or derived from criminal activity. The 1st stream consists of Criminal Code Part XII.2, CDSA s. 16 and other statues, *Criminal Organizations Act* et al., and the 2nd stream consists of Alberta Civil Proceeds for forfeiture pursuant to the *Victims Restitution and Compensation Payment Act*.

WIRETAPS

Gary H. Cornfield Q.C., Alberta Justice; Karen B. Molle

This topic will explore the non-Charter based attack on the wiretap; the focus will be on finding flaws in the integrity of wiretap evidence. Presenters will describe the procedures the police use to intercept private communications and will explain how the Crown introduces wiretap evidence at trial. Discussion will include implementation of the authorization, minimization clauses, monitoring issues, voice identification, foreign language transcripts, and potential issues regarding the integrity of the recordings.
