Features of the Workshop include:

- **Working small groups** The faculty to student ratio is 12 instructors to 32 students.

- **Faculty of experienced trial judges and lawyers** Access the skills and knowledge of experienced trial judges and some of Saskatchewan's finest courtroom practitioners.
- **Curriculum** Exercises will be drawn from two case files, one civil and one criminal. The exercises will develop your skills in direct and cross examination, use of exhibits, witness impeachment, re-examination, demonstrative evidence, and opening and closing statements.
- **Faculty critique and constructive suggestions** After each skills performance, you will receive constructive feedback from your instructors. Learn from your own performance and those of other participants. Demonstrations by instructors will provide you with the opportunity to observe effective advocacy skills.
- **Video** Review your video performances for additional feedback.

- You will receive the case files and reading assignments for review and preparation several weeks in advance of the Workshop. Please come prepared.
- Participants will be involved throughout the Workshop with performing various skills exercises. When you are not actually performing, you are expected to watch and learn from other performances. Full attendance for the entire Workshop is required.
