



INTEGRITY:

Good People, Bad Choices, and Life Lessons from the White House

In his course, *INTEGRITY: Good People, Bad Choices, and Life Lessons from the White House*, Egil "Bud" Krogh describes his unique experiences on Richard Nixon's White House staff. He explains how the "slippery slope" of little decisions that lack integrity – such as a police badge for Elvis Presley, the fat content in the American hot dog, and a botched nomination of a US Supreme Court Justice can lead to a major meltdown such as a break-in to the office of Dr. Louis Fielding, Dr. Daniel Ellsberg's psychiatrist. Dr. Ellsberg had leaked the Pentagon Papers, a top secret history of the Vietnam War, to the New York Times. The leak infuriated President Nixon and he instructed Mr. Krogh that such leaks "would not be allowed". The Fielding break-in led to Watergate, a massive cover-up, and the first resignation of a serving US President. From his experience, Mr. Krogh has developed The Integrity Zone®, a model for making decisions that are based on integrity and are whole, right and good. He offers examples of how critical it is to be aware of the context in which one is working to avoid external and internal threats to integrity, including secrecy, groupthink, pressure for results, arrogance, misplaced loyalty, and blind ambition.

His message today is the same as at his 1974 sentencing hearing, when he said: "I hope that the young men and women who are fortunate enough to ... serve in government can benefit from this experience and learn that sincerity can often be as blinding as it is worthy."

Speaker

Egil "Bud" Krogh joined the Center for the Study of the Presidency and Congress in January 2009 as a Senior Fellow on Leadership, Ethics, and Integrity, a year after speaking at the Center's National Consortium for Character-Based Leadership. Over the last 5+ years, Bud has focused on spreading the message of integrity-based decision making through youth, corporate, public service, and legal education. In 2007, Public Affairs Press published his book *INTEGRITY: Good People, Bad Choices, and Life Lessons from the White House*.

Bud's work on integrity is rooted in his experiences at the highest levels of decision making. After a tour with the Navy during the Vietnam War followed by graduation from law school (where he was an editor at the University of Washington Law Review), Bud joined John Ehrlichman's staff as Assistant to the Counsel to the President at the beginning of Richard Nixon's first term. During his time on the White House staff, Bud's responsibilities included District of Columbia governmental affairs, law enforcement, narcotics control policy, and transportation policy.

As co-director of a Special Investigations Unit, eventually known as the "Plumbers," Bud approved a covert operation as part of a national security investigation into the leak of the Top Secret Pentagon Papers to the New York Times. He later pleaded guilty to conspiracy and served four and half months in prison. Bud has had 35 years to reflect on the lessons learned from his experience in the White House and their relevance to more recent political and business scandals. Some of his conclusions have resulted in The Integrity Zone®, a decision-making model intended to help people make choices based on integrity in their professional and personal lives.
