Please note that your name and contact details will appear on the Locum Lawyer Registry. You will not have to renew your profile. It will be included on the Locum Lawyer Registry until you submit a written request to have it removed. You may revise or remove your profile at any time.

To be eligible to post your profile on the Locum Lawyer Registry, you must be a Member of the Law Society of Saskatchewan who is entitled to practise law in Saskatchewan. The Law Society of Saskatchewan will verify this information. You must notify the Law Society immediately should you become ineligible to act as a Locum Lawyer.

Locum Lawyer Registry Consent and Declaration

I have read the materials regarding the Locum Lawyer Registry on The Law Society of Saskatchewan's (the "Law Society") website and I agree to apply and participate in the Locum Lawyer Registry (the "Registry").
