**ORDER**

Before the Honourable Mr. Justice J.A. Tholl in chambers on the 26<sup>th</sup> day of October, 2017.

On the application of Timothy Huber, lawyer on behalf of the Applicant and on reading the within Originating Application, and Affidavits of Uti Oghenekohwo, Tara Kovacs, Christopher Wilson, Jennifer Hiatt, Norman Bercovich, Stacey McPeek and Aynsley Calder,

The Court orders:

1. Pursuant to Rules 3-2(1)(b) and 3-2(6) of *The Queen's Bench Rules* and s. 82(1) of *The Legal Profession Act, 1990* (the "Act"), The Respondent is restrained from:
  - (a) Practicing at the bar of any court of civil or criminal jurisdiction in Saskatchewan;
  - (b) Advising, for a fee or reward, either directly or indirectly, in matters pertaining to the law of Saskatchewan or of any jurisdiction outside Saskatchewan.
  - (c) doing or performing any work or service for fee or reward, either directly or indirectly, in matters pertaining to the law in Saskatchewan or of any jurisdiction outside of Saskatchewan.
  - (d) suing out any writ or process.
  - (e) commencing, carrying on or defending any action or proceeding in any court of civil or criminal jurisdiction;
  - (f) pretending or holding herself out to be a legal service provider, lawyer, or an attorney at law, or a barrister, or a solicitor;

- (g) taking, assuming or using any name, title, addition or description other than one that she actually possesses and is legally entitled to, or that implies or is calculated to lead people to infer that she is a lawyer, an attorney at law, a barrister, or a solicitor, or that she is a lawyer or member or is recognized by law as a lawyer qualified to practice law or do business as a lawyer in Saskatchewan or any jurisdiction;
- (h) publishing or advertising herself as a lawyer, an attorney at law, a barrister, or a solicitor in or on any print or broadcast media or electronic media, including web sites and social media; and
- (i) using the designations of "barrister", "solicitor", "barrister and solicitor", "lawyer", "legal practitioner", "attorney-at-law" or "attorney".

2. The Respondent is restrained from doing any of the above in the guise of agency;

3. The Applicant shall have the costs of this application in the amount of \$1,000.00, forthwith payable by the Respondent.
