Mental health and resiliency are important discussions in our world today. This seminar will offer the participant insight into the stigma of mental health in the practice of law, information on available mental health resources, and education on building tools to be resilient.

The seminar will end with information on local resources available for lawyers dealing with mental health.

Nichele Nicole (Nikki) Johnson holds both a Bachelor's and Master's degree in Education with a minor in Psychology. They have both retired from the U.S. army and continue to instruct at the U.S. Army Master Resilience School at Fort Jackson.
