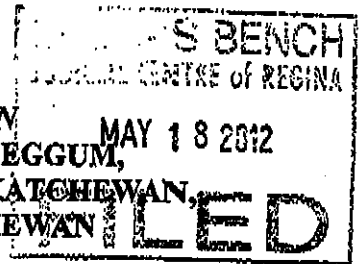

IT IS HEREBY ORDERED that:


1. Pursuant to s. 61(2)(a)(i) of *The Legal Profession Act*, 1990, *supra*, Michelle Ouellette, Q.C. of McKercher LLP shall be appointed as Trustee, without bond, to take control and/or possession of the law practice of KRISTIAN EGGUM, including all records and other property pertaining to KRISTIAN EGGUM's practice and any trust held in connection with the legal practice of KRISTIAN EGGUM;
2. Pursuant to s. 61(2)(a)(ii) of *The Legal Profession Act*, *supra*, the Trustee shall be authorized to do anything that KRISTIAN EGGUM was capable of doing in connection with his practice with full authority to manage and subsequently wind up his practice;
3. Pursuant to s. 61(9) of *The Legal Profession Act*, *supra*, the Trustee, shall be authorized to attend and enter the premises of KRISTIAN EGGUM located at #101 88 - 13th Street East, Prince Albert to:

- (a) Examine KRISTIAN EGGUM's offices and connected premises;
 - (b) Take control and/or possession of anything that there are reasonable and probable grounds to believe constitute KRISTIAN EGGUM's records or property that pertain to his law practice including but not limited to paper files, trust records and computers; and
4. Pursuant to s. 61(6) of *The Legal Profession Act, supra*, the Order shall be personally served upon KRISTIAN EGGUM forthwith along with his partner Peter V. Abrametz and associate Krista Eggum;
 5. Pursuant to s. 61(2)(c) of *The Legal Profession Act*, any and all financial institutions or other depositories of KRISTIAN EGGUM's records and other property shall hold, pay over and deliver any of that property to the Trustee upon request by the Trustee;
 6. In winding up the Member's practice, and transferring carriage of legal matters to other practitioners, the Trustee shall give preference and right of first refusal to the remaining practitioners in the Member's firm, Peter V. Abrametz and Krista Eggum, unless in the trustee's sole discretion it would be inappropriate to do so; and
 7. The Affidavit of Jennifer Houser filed in support of this application shall be kept confidential and not released to the public without further order.
