- 1. Pursuant to s. 61(2)(a)(i) of *The Legal Profession Act*, 1990, *supra*, DAVID HICKIE shall be appointed as Trustee, without bond, to take possession of the law practice of DMYTRO IGNATIUK, including all records and other property pertaining to DMYTRO IGNATIUK's practice and Ignatiuk Law Offices and any trust with respect to which DMYTRO IGNATIUK is or was a sole trustee;
- 2. Pursuant to s. 61(6) of *The Legal Profession Act, supra*, the Order shall be personally served upon DMYTRO IGNATIUK forthwith;
- 3. Pursuant to s. 61(2)(c) of *The Legal Profession Act*, any and all financial institutions or other depositories of DMYTRO IGNATIUK's records and other property relevant to Ignatiuk Law Offices shall hold, pay over and deliver any of that property to the Trustee upon request by the Trustee; and

4. Nothing in this Order is intended to invalidate or cancel any existing Succession Agreement between DMYTRO IGNATIUK and the Trustee.
