



## Family Law: Through The Eyes of The Child

This important session has been conceived of by a group of family law practitioners and judges with the express purpose of aiding lawyers in navigating the murky waters of high conflict parental separation and disputes. It seeks to offer a basic understanding of the pathologies underpinning these often-fraught situations and some remedies for ensuring the best interests of the children are always kept in the forefront of proceedings.

We are delighted to be welcoming **Dr. Craig Childress**, a renowned Clinical Psychologist who specialises in Parental Alienation Dynamics and has worked extensively within the court system, most recently piloting a program for Houston, Texas's Family Courts. The mission and goal of the Houston program for the family courts is to provide the court with the highest caliber of professional knowledge and standards of practice in clinical psychology. Dr. Childress will spend the morning discussing his Attachment-Based Model of Parental Alienation (AB-PA) and how it can be utilized in aiding family courts, family law practitioners and professional psychologists.

The middle section of this day-long seminar will be dedicated to offering our attendees details of the various resources and programming available in Saskatchewan to keep these high conflict matters out of the courts. We will hear from members of the *Aspire Too* counselling team who work with families who are experiencing high conflict divorce and prepare assessments for individual families, lawyers and the Government of Saskatchewan. The Family Justice Services Branch, Program Manager will discuss the resources available through their office. A Consultant from the DRO will discuss high-conflict mediation as well as offer an update on the proposed change to a mandatory mediation for family law model here in Saskatchewan. Our *Alternatives to Court* section will be concluded with a look at innovations in the delivery of Family Law services with two practitioners who are committed to doing things in a different way.

The seminar will be completed with a panel discussion on *When Court is Necessary*. This will be another practical session aiming to arm lawyers with the tools and expertise to recognise when court is necessary and how to successfully prepare materials for court. A perspective from the Bench will be offered, as will further discussion of Dr. Childress's Houston Model.
