2.3 Member Data and Annual Renewal

At June Convocation, the Benchers approved the implementation of a revised approach to demographic data collection practices, updates to language and enhancements to searchability features in the external (Find A Lawyer) directory to be implemented in conjunction with annual renewal.

As was anticipated in June, advice was sought on inclusive language use and good practice resulting in revisions to demographic data collection language and to the external lawyer directory, including allowing lawyers the option of displaying gender pronouns. The Equity & Access Committee has provided their feedback on changes.

A memo from Administration outlining progress to implement improvements to member data collection is attached.

3. Bencher Election

Nominations closed on October 4th. Voting will be required in four electoral divisions: North West (two candidates); New Lawyer (3 Candidates); Regina (9 candidates); and Saskatoon (6 candidates). Candidates in all other electoral divisions are acclaimed, with the exception of the South East electoral division where no nominations were received. Members eligible to vote will receive instructions to access the voting platform and voting credentials on November 1, 2021. Voting will close on November 15, 2021 at midnight.
