The meeting was called to order at 11:04 am.

1. Approval of the Agenda

2. Governance

2.1 Financial Statements

Financial Statements for the period ended September 30, 2021 were provided and would not be addressed, as they form part of the budget.

2.2 Budget 2021 (In-Camera)

This portion of the meeting was held *in camera*. Meeting materials for this portion of the meeting are of a confidential nature and are not available to the public. A memo prepared by Tim Brown, Q.C., along with the following documents, were provided for Bencher review and discussion:

Other documents relating to the budget were the 2022 Budget 3-year forecasts and reserve balances (General and Special Fund).

Tim Brown, Q.C. presented the proposed budget to the Benchers.

A motion to approve the 2022 budget, as presented, was moved by Ian Wagner, seconded by Barbara Mysko. The motion carried unanimously.

A motion to approve the practicing fee for 2022 at \$2,175, unchanged from 2021, was moved by Jeff Baldwin, seconded by John Morrall. The motion carried unanimously.

A motion to approve the Special Fund assessment for 2022 at \$100, unchanged from 2021, was moved by Craig Zawada, Q.C., seconded by Nolan Kondratoff. The motion carried unanimously.

A motion to grant second reading on the same day was not required, as the Practice Fee and Special Fund Assessment remained unchanged from 2021.

Administration recommended the establishment of a Committee to examine the future of Law Society fees and reserve fund strategies. There are significant decisions to be made which are too complex to fully consider in a 2-hour Annual Budget meeting. Details regarding the composition of the Committee will be determined at a later date.

Moved by Leslie Belloc-Pinder, Q.C., seconded by Suzanne Jeanson, to approve the formation of a new Law Society Committee to examine the future of Law Society finances. One opposed. The motion carried.

2.3 Member Data and Annual Renewal

At June Convocation, the Benchers approved the implementation of a revised approach to demographic data collection practices, updates to language and enhancements to searchability features in the external (Find A Lawyer) directory to be implemented in conjunction with annual renewal.

The goal is to be more inclusive and to allow members to identify in ways that they have not been able to do so before. What we learn today and the language that we use will continue to change as we learn more about society and the community. Advice was sought on inclusive language use and good practice resulting in revisions to demographic data collection language and to the external lawyer directory, including allowing lawyers the option of displaying gender pronouns. The Find Legal Services database will also be re-designed making it more user friendly and informative for the public.

Following discussion, the Benchers authorized the Administration to proceed as outlined in the memo.

Nominations closed on October 4th. Members eligible to vote will receive instructions to access the voting platform and voting credentials on November 1, 2021. Voting will close on November 15, 2021 at midnight.
